



TERMS OF SERVICE

Last Updated: July 14, 2026

These Terms of Service (“Terms”) govern your access to and use of **rootedapp.faith**, including its pages, content, features, and materials (collectively, the “Site”).

The Site is owned and operated by **Rooted App, LLC**, a Missouri limited liability company (“Rooted,” “we,” “us,” or “our”).

By accessing or using the Site, you agree to these Terms. If you do not agree to these Terms, please do not use the Site.

1. Website Purpose

The Site is an informational and educational website intended to provide information about Rooted, its mission, its anticipated or available products and services, its faith-based content, and its impact initiatives.

The Site is separate from the Rooted mobile application. These Terms apply only to rootedapp.faith unless another Rooted service expressly incorporates them.

Use of the Rooted mobile application may be governed by separate terms, privacy notices, subscription terms, app-store requirements, or other agreements.

2. Educational and Faith-Based Information

The Site may contain Christian, biblical, devotional, inspirational, educational, charitable-impact, or general wellness-related content.

This content is provided for general informational and educational purposes only. It is not intended to replace professional medical, mental-health, psychological, legal, financial, tax, crisis-intervention, or other professional advice.

3. Eligibility

This obligation does not apply to the extent a claim results from Rooted's own unlawful conduct.

12. Governing Law and Venue

These Terms are governed by the laws of the State of Missouri, without regard to conflict-of-law principles.

Unless applicable law requires otherwise, any legal action arising from these Terms or the Site must be brought in a state or federal court with jurisdiction in or serving Jackson County, Missouri. You and Rooted consent to the personal jurisdiction of those courts.

Before initiating formal legal proceedings, you are encouraged to contact us so that we may attempt to resolve the matter informally.

13. Changes to These Terms

We may update these Terms as the Site, our business practices, or applicable requirements change.

When we update these Terms, we will revise the "Last Updated" date at the top of this page. Material changes may also be communicated through an additional notice on the Site when appropriate.

Your continued use of the Site after updated Terms become effective constitutes your acceptance of the revised Terms.

14. Severability and Waiver

If a provision of these Terms is found to be invalid or unenforceable, the remaining provisions will remain in effect. The invalid provision will be interpreted or modified to the minimum extent necessary to make it enforceable where permitted.

A failure by Rooted to enforce a provision of these Terms is not a waiver of that provision or any other right.

15. Entire Agreement

These Terms, together with the Website Privacy Policy and any additional notices expressly incorporated into them, constitute the entire agreement between you and Rooted regarding your use of the Site.
